1. Apologies

2. President's Report

Jude M explained that there would not be a President's report because Matthew was unable to attend and because there was not much activity last year due to Covid-19.

3. Treasurer's Report

Iwona U gave the Treasurer's report. The school was successful in obtaining a \$20,000 grant which will be used for improvements to the school grounds. There was no other fundraising due to Covid-19.

The \$20,000 will be transferred to the school as soon as the authorities for the bank account are updated following the AGM. The additional funds will be used for the P&C insurance etc.

Iwona U circulated the audited financial statements of the P&C for the last two financial years (2018/19 and 2019/20). Both years were provided because the P&C was not able to hold its AGM last year due to the pandemic.

4. Elections

Lyn S agreed to be returning officer for the election.

Jude M gave an explanation of the roles and emphasised that we will be supportive if people aren't sure but want to give it a go.

Lyn S called for nominations for the Treasurer position. Jude M nominated Iwona U.

The members unanimously elected Iwona U as Treasurer.

Lyn S called for nominations for the Secretary position. Anna H nominated herself.

The members unanimously elected Anna H as Secretary.

Lyn called for nominations for the Vice-President position. Shivani V, Habiba K and Mamta T nominated themselves. It was agreed that the P&C could use three vice-presidents. It was suggested each Vice-President could take on a different role, for example one could focus on social media, one could support

Treasurer and look at fundraising and one could support the Secretary. Habiba K noted she has experience in social media.

The members unanimously elected Shivani V, Habiba K and Mamta T as Vice-Presidents.

Lyn S called for nominations for the President position. Lyn nominated Jude M for President.

The members unanimously elected Jude M as President.

Lyn S handed the meeting back to Jude M.

5. Appointment of auditor for next year

Jude M noted that this year's auditor, Stella Jahya, is a parent at the school who volunteers her services for the P&C's audit for the last two years. Jude M proposed the appointment of Stella Jahya as next year's auditor.

The members unanimously resolved to appoint Stella Jayha as the auditor.

6. Financial statements

Anna H moved that the P&C accept the audited Financial Statements for 2018/19 and 2019/20. Iwona U seconded.

The members unanimously accepted the audited financial statements for 2018/19 and 2019/20.
